I am currently Chair Professor in the Faculty of Law of the Chinese University of Hong Kong (CUHK). Prior to joining CUHK, I was a tenured staff member in the Faculty of Law at the University of New South Wales (UNSW), where I now hold a position of Adjunct Professor. I am also Li Ka Shing Visiting Professor in McGill Law School, Honorary Professor at East China University of Political Science and Law, as well as visiting positions at many prestigious institutions such as Harvard Law and Oxford Law. I received two bachelor degrees – in mechanical engineering and in law – and a Masters degree in law, from Tsinghua University, and a PhD in law from UNSW.

I am an internationally recognized expert specializing in corporate law, securities regulation, financial regulation, foreign investment, and law & technology, with a particular focus on the case of China, from comparative and empirical perspectives. I have had more than 150 publications in my areas of expertise, with articles published in top-rated journals in the US, the UK, Australia, Canada, Germany, Israel, Hong Kong, Mainland China, and elsewhere, including American Journal of Comparative Law (3 times), ¹ Vanderbilt Journal of Transnational Law, Delaware Journal of Corporate Law, Journal of Corporate Law Studies, Banking and Finance Law Review, European Business Organization Law Review, Journal of International Economic Law, as well as Chinese core law journals such as Chinese Journal of Law [法学研究], China Legal Science [中国法学], Peking University Law Journal[中外法学] and Tsinghua Law Review[清华法学].
